



Memo of Understanding

A Memo of Understanding (MOU) is a document that describes a formal agreement between two parties. It is not a legal agreement, it indicates the establishment of a business relationship. The purpose of this MOU is to establish a **Formal Partnership** between the Wisconsin Off-Road Vehicle Park, Inc. (WORVPI) and the Wisconsin Four Wheel Drive Association (W4WDA). This Partnership is intended to assist in facilitating the establishment of a Motorized Recreation Area (MRA) in Northern Wisconsin.

Agreements of Understanding

1. WORVPI's mission is "Providing economic development through a recreational venue which educates and encourages the principles of safe and responsible motorized recreation."
2. W4WDA's mission is "To preserve and promote the off highway use of four wheel drive vehicles in Wisconsin on public and private land by working with federal, state, county and local governments. To promote good trail and conservation practices for enjoyable family recreation."
3. WORVPI and W4WDA are partnered in a joint effort to establish a MRA in Northern Wisconsin.
4. WORVPI will provide expertise in site selection, engineering services, funding, land acquisition, operation & business plan development, MRA management, trail volunteer training, and all areas specific to securing, developing, operating & maintaining of the MRA.
5. W4WDA will encourage and support creation of a roster of potential volunteers to serve as a source of labor in trail development and maintenance within the MRA.
6. Both WORVPI and W4WDA will support each other in the matters listed above. Including support of the mission of the other.

7. No financial commitment on behalf of either WORVPI or W4WDA, to the other partner is entered into or implied by this MOU.
8. Both WORVPI and W4WDA will allow and encourage to use of their corporate logo in advertising, educational and marketing materials (at their own expense).
9. Both WORVPI and W4WDA agree to indemnify against the other parties actions, including their officers, agents and members.

The undersigned, on behalf of WORVPI and W4WDA, agree and understand the above statements. Further, both the undersigned have the authority to represent and commit their respective entities to this MOU.
